Statistical violations mentioned in the 12th report of the Committee for the Defence of press freedom of the Kurdistan Syndicate of Journalists, is increased during the past six months if compared to the first six months of 2013, as well as a growing proportion, with the deepest regret was the assassination of journalist martyr « Kawa Ahmad Garmeany « the Editor-in-Chief of the (Rayal) magazine which is recorded in the 12th report, too. In addition to the beatings cases because of various factors. Especially during the election process of the Kurdistan Parliament and explosions which occurred in front of the "Asayish" in Erbil and the Ministry of the Interior. These are all unhealthy indications of the press situation in Kurdistan Region.

The number of violations might be more than it is included in the report. However, violations which are recorded by the Committee for the Defence of violations according to the complaints of journalists are officially submitted to the Committee through the branches and offices of the syndicate. All the necessary follow-up actions were taken in this regard. As a result it was confirmed that the total number of violations that comes in the 12th report was (27) against (42) journalists.

The deep concern of the Kurdistan Syndicate of Journalists has always been and remains is the implementation of the Press Law No.(35) issued in 2007 and never attempted to interfere any legal

procedures taken by the judicial authority of the Kurdistan region; except the issues concerning the press and freedom of opinion and expression, that will be dealt outside the framework of the mentioned law.

Here again based on our faith to the principles of human rights and the defence of journalists and freedom of opinion and expression, we call on magistrates not to deal with the texts of laws which will be incompatible with the press act. As we ask the Kurdistan Regional Government , especially the Ministry of Interior and the security authorities to follow-up the violations which are committed against the journalists by their own staff. Unfortunately despite the formation of several joint committees and coordination between the Ministry of Interior and the Kurdistan Syndicate of Journalists, Yet, there is no legal procedures have been taken as it is required against those who committed the violations against the journalists which is mentioned in our previous reports of (the 11th) one.

At the same time we call on all the journalists and media professionals, to take in consideration their professional rights and duties with responsibility and committed to the standards of professional ethics and international press to perform their duties under the law of professional journalism.
