Towards a Wider Scope of Freedom

One of the most important tasks of Defense Committee of Journal Freedom and the Journalists' Rights on Journalism in Kurdistan Journalists Syndicate is that every six months publicizes a report to General opinion on the Journalists' circumstances in Kurdish, Arabic and English languages, including data of all violations done against Journalists in Kurdistan Region. The report number 17 is about the first six months of the year 2016, although this report has been publicized in its time with the report number 18 of the second six months of 2016 as annual general report and comparing with violations of the year 2015 with the year 2016 in a table and publicized to general opinion. The total violations done against the journalists in the year 2016 are 45 violations. The violations are various. The violations done against the journalists were 80 while the violations done against the journalists in the year 2015 were 32; the cases were various done against 72 journalists.

Here we would like to show the opinions of Defense Committee of Journal Freedom and the Journalists' Rights and the cause of continual and increasing violations against the journalists in Kurdistan Region; we want to illustrate all these in the following points:

- Continual terror and killing the journalists and postponing and neglecting the cases of the journalists killers for long time and not capturing the killers of journalists are pieces of evidence that the Kurdistan is going to be a peaceful place to the killers of journalists, all these are to be puzzles, and the political authority, the trial policy in Kurdistan Region in front of the Defense organizations of Human Rights and opinion and Journal freedoms, are under serious questions.
- When there are conflicts and disputes among the political parties in Kurdistan, the most dangerous situations happen to the journalists and the journal establishments, this will be opposite when the conflicts go down among the political parties, as well as the rate of violations will be lesser and lesser, this circumstance is obviously seen and felt in the reports of the Defense committees.
- One of the causes of violations of the journalists by the media establishments are lack of working contracts among some of journal and informing establishments or not declaring the contents of the contracts or not certifying in Journalists Syndicate which is in the item 7 of the article 7 in the journal law in the number 37 for the year 2007.
- Not implementing of the law of right to obtain information and unfairly giving information to the journalists and media.

- Lacking of experience of some journalists and media establishments in covering forwarding and victories of Peshmarga Force
 in the border of battle against the ISIS Terrorists which sometimes will have negative effects on military, logistic even
 psychological aspects.
- Because of continual crisis of economy, tens of broadcasters, information establishments stopped from work and many media men are jobless. This case being to be away from the task will have negative effects on the journalists' rights and life.
- Having lack of trust among the journalists and some of courts have made the journalists when the violations are done against them, they will not register legal compliance in the courts.
- Not implementing the journal law number 35 for the year 2007 in Kurdistan Region in some of the courts, although this case
 has now become rare.
- Some of media in Kurdistan especially in radios and TVs via their programs instead they leave positive roles on principles of peace in society and coexistence they oppositely cause to separate the pillars and principles of society.
- Lack of experience of some journalists about professional measurements and lack of information about law rules especially of Journal Law in Kurdistan, this of lack has made the journalists not to be familiar of their duties and rights.
- Not being aware of media tasks and effects and not understanding of them by some government and party officials.

Finally we ask political parties and governmental officials to respect journal law and journal professions especially journal freedom and journalists' rights, this is because the journalists and information establishments have effective role in developing nation and nationality issues and stepping to democracy installation in Kurdistan region, we also ask the journalists to depend on the frame of law to Journalism ethics and standards and they implement their tasks of journalism in the case of any violations done against them by any people or any party and under any justifications, after that as soon as possible they inform the Defense Committee and register legal compliance in the courts.

For the sake of freedom installation of journal freedom and obtain the journalists' rights with opinions difference even they are not members of syndicate, Defense Committee keep defense on their rights.

We hope that the year 2017 will become widening for journal freedom and obtain the journalists' rights and bettering the journalists' livings in Kurdistan Region.

- 1- Various violations were done against many journalists and Kurdistan Region Media out of Kurdistan border; this was not registered in Defense Committee. But the report of Defense Committee is about publicizing the statistics of violations done against the journalists of inside of the Kurdistan border, so any violations done out of the Kurdistan border are not publicized in this report.
- 2- Concerning the case of the journalist's death, Shukri Zainadin, after following up the case by the Defense Committee, it has become clear that the journalist's death was not the result of the journal work but the case and the happening of the death was of another unwanted matter.
- 3- In the report of Defense Committee of the journalists' rights, all violations done and followed up have been certified and they have been publicized in two chapters of this report.
