Therefore, we believe it is necessary to renew the call to security and judicial institutions to work according to the articles and articles of the Journalistic Work Law (35) Dealing with journalists' files according to this law.

At the same time, we call on dear journalists to adhere to professional standards for journalistic work and to stay away from integrating political position in media work. We assured everyone that the Committee for Defending Press Freedoms and the Rights of Journalists will continue Its desperate defense of journalists, media and press institutions..

The Committee for the Defense of Press Freedoms and the Rights of Journalists, and a cornerstone of the Kurdistan Journalists Syndicate, has continued to perform.

Its tasks are to monitor the conditions of journalists and press institutions, as well as the violations committed against them. The obstacles facing the work of journalists have increased, which leads to an increase in violations, especially at the time of protests and demonstrations. The expansion of the base of electronic media and communication sites has caught the attention of the last six months, which led to this expansion. all regions in general, and Kirkuk Governorate in particular, In which systematic violations were practiced in advance by the security services and militias in the regions of Kirkuk, which necessitated the General Secretary of the Kurdistan Journalists Syndicate in the matter by sending a memorandum to the Prime Minister of the Iraqi government,

We also demanded at the same time the position of the Iraqi Journalists Syndicate without touching any positive response from it, it is worth noting that we noticed that some of the security forces participating in the lockdown were not aware of the journalistic work law in force in the Kurdistan Region despite their cooperation and their role in preserving the health of citizens. In addition, a number of journalists took advantage of the facilities provided to journalists during the ban periods in one way or another. It is regrettable that a number of media and press channels downplayed the seriousness of the Corona Virus Pandemic and urged citizens not to be careful of the threat of the virus and underestimated preventive measures. The work is against the directives of the Ministries of Health and the Interior, and this is not in the public interest and is considered outside the frameworks of national action. Therefore, we call once again on those media and press institutions to discard such trends and to work professionally and in line with the public interest.

Introduction

The Committee for Defending Press Freedoms and Journalist Rights in the Kurdistan Journalists Syndicate presents its report on the number of violations against journalists in the first six months of 2020.

This report, which carries the number (25), includes among its contents the violations that were recorded between the periods from 1/1/2020 until 6/30/2020...

At the beginning of the Corona virus crisis, and the measures that accompanied it from the lockdown, we expected a significant decrease in the number of violations against journalists, but unfortunately, the rate of violations increased compared to previous years. Journalists were subjected to numerous violations while covering news related to the Corona pandemic and following up on the conditions of the injured, and they suffered from bias when obtaining information. The Kurdistan Journalists Syndicate has made great efforts in directing journalists to prevent the virus, through its office For occupational Safetythrough the guidelines of the International Federation of Journalist IFJ and Distributing it to media institutions, and also through the directives of the Committee for the Defense of Press Freedoms and the Rights of Journalists. However, unfortunately, 84 journalists from the Kurdistan Region, including Kurdish regions outside the region's administration, Were infected by the Corona Virus, and one journalist died in the city of Sulaymaniyah. We present this report, which reveals the conditions of journalists in
