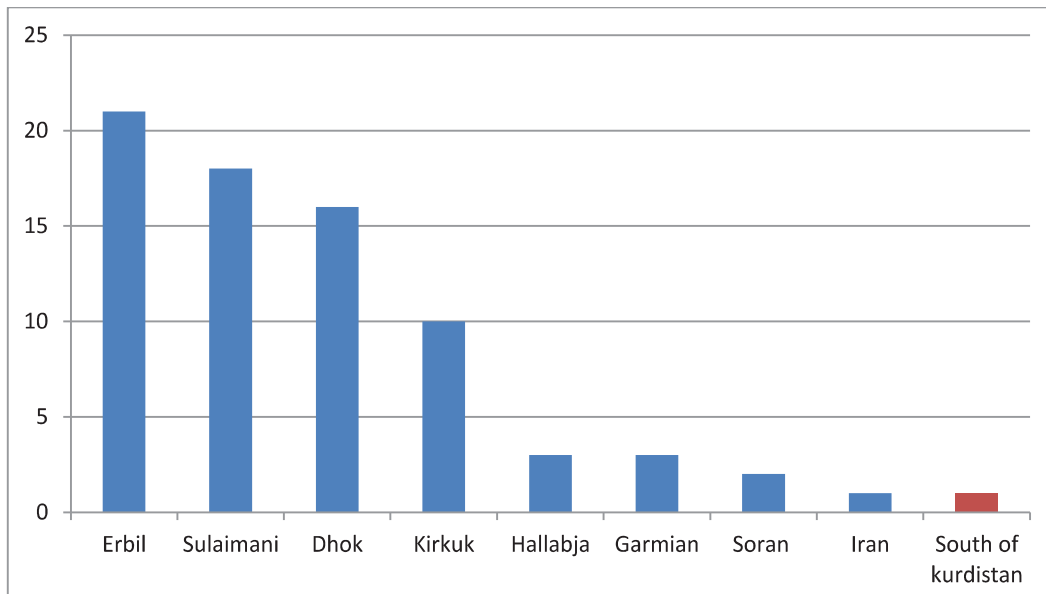

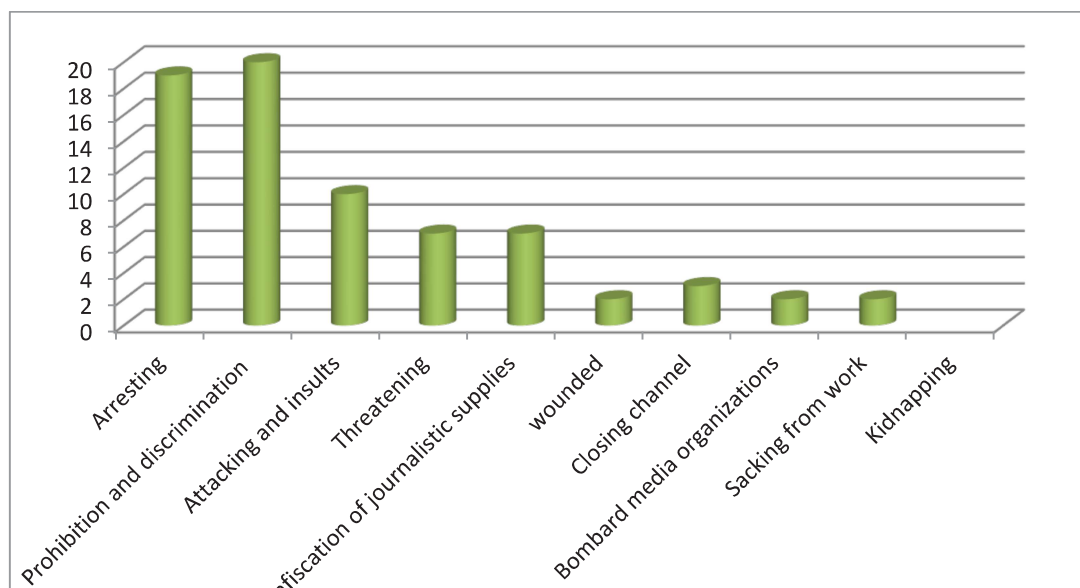

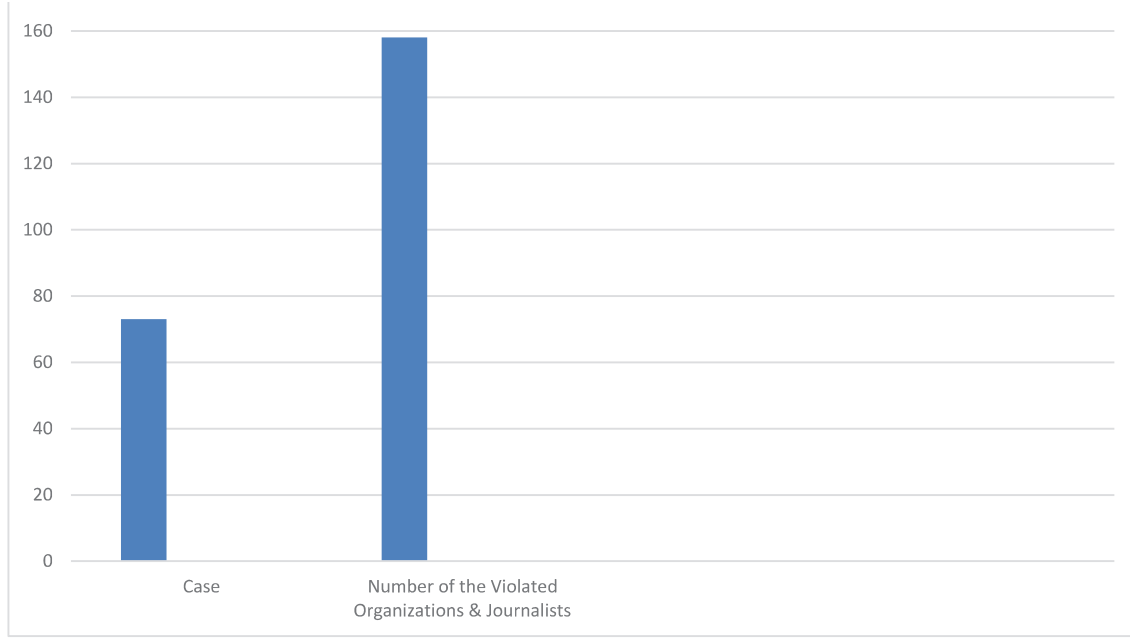

.. It is no secret that this issue poses a threat to the democratic process in the Kurdistan Region, and these violations have negatively affected the Kurdistan Region. Therefore, we call on the relevant authorities to work as soon as possible to stop these violations, according to the following points...

* Commitment to prevent discrimination between the sexes at work, especially as we witness the active participation of female journalists in the Kurdistan region in press and media institutions. And putting an end to violations against women journalists such as (sexual harassment, discrimination in rights and duties) by enacting a law to preserve the rights of women journalists.

* Changing the view of the relevant authorities on journalists and not dealing with them with hostility, but rather according to the paths of democracy

* We call on the Parliament of the Kurdistan Region to work in cooperation and coordination with the Kurdistan Journalists Syndicate to amend Law No. ٣٥ of journalistic work in a manner consistent with the developments that occurred in journalistic work so that the amendment includes all aspects of journalistic work so that media institutions perform their tasks more professionally and taking into account the privacy of each type of press and media in order to be Proper and professional handling of information and news sources...

Introduction

The series of violations against journalists continues in the Kurdistan Region, and thus the freedom of journalistic work remains threatened under these circumstances. Therefore, the Committee for the Defense of Press Freedoms and the Rights of Journalists is obligated to present these violations, which it hoped that the past year would be a year in which violations against journalists would be free, but this wish was not fulfilled. Rather, other types of violations were practiced in other ways against journalists, such as breaking press supplies such as cameras and confiscating mobile devices. And scanning the content of videos, photos and other press supplies

In addition to the injury of a number of journalists, which is considered a serious phenomenon witnessed by the violations against journalists last year, which our committee recorded in this report, in addition to other ongoing violations such as preventing the practice of the profession, discrimination at work, belittling and threats.

What we refer to and stop at is the increase in electronic pages, as large numbers of them operate in the Kurdistan Region, far from any correct foundations and without taking into account the values of journalistic work.

Unfortunately, some of them violate the ethics of journalistic work, as well as by passing the journalists themselves by filing charges by publishing fabricated news against journalists.

Unfortunately, this work entered into political conflicts, which was reflected in the credibility and professionalism of journalistic work and became a dangerous link to the established and true values of this journalistic work, in addition to the Misinformation and fake news that is published on these websites and electronic pages. Which negatively affects the psyche of the individual in society, and this needs to put an end to this chaos by enacting a law to regulate the work of these sites.

We take into account these risks that we mentioned in order to enhance press freedoms and reduce violations, especially since the issue of violations against journalists and chaos in journalistic work is of concern to international centers at the present time.
